#### Background



- Highest level determination to equip Senegal with a high-performance health and social action system
- Evidenced in the Emerging Senegal Plan (PSE) implemented by Ministry of Health and Social Action's Sectoral Development Policy Letter (LPSD) and the National Health and Social Development Plan (PNDSS).
- An increase in healthcare provision and equity of access to care, notably through the Universal Health Coverage (CMU) initiative
- Improved social care for the most vulnerable populations.

1. Pharmacy

- 2. Digitization
- 3. Reforming hospital governance and the private health sector

4. Creation of the Legal Affairs Department

### Reform in Pharmacy

- Reform of the local pharmaceutical industry backed by institutional, and legislative and regulatory changes.
- Enabled local manufacturers to produce sufficient quantities of the medicines and other health products that are essential for supplying the country and reducing imports.

## Reform in Pharmacy: Institutional

- Delivery Unit (or Management Unit) for the re-launch of the local pharmaceutical industry;
- Agence Sénégalaise de Réglementation Pharmaceutique (ARP) was set up as a result of the integration of the LNCM and the DPM
- Establishment of the PNA as an industrial and commercial Public Establishment called SEN-PNA.


## Reform in Pharmacy: Legislative and Regulatory

Adopted a new law in 2023 (repealed 1954 law) and 6 implementing decrees:

- bring regulations in line with new developments
- provide local industry with an appropriate legal framework by opening up majority share capital to non-pharmacists.

## Creation of the Legal Affairs Department

- support for central departments and services and decentralized entities
- coordination of the department's standards policy and reforms, and activities.
