



# Casting doubt on evidence of harm


"Cancer is a very complex disease. Many factors have been associated with this disease besides smoking, including occupational and environmental exposures, diet, viruses, heredity and stress. Clearly there are many gaps in knowledge about lung cancer that only further research will resolve." BAT, 1992

"Earth's climate is affected by many complex variables, such as sunlight, clouds, rain, wind, ice, storms, lightning, volcanoes, comets, magnetic fields and living organisms, including humans. Throughout history, climate has fluctuated between periods of cooling and periods of warming." ExxonMobil, 1998

"We believe obesity is a complex problem which cannot be reduced to the demonization of one ingredient... there is no simple answer to the complex problems of obesity" Food and Drink Federation, 2015 "Is there a cause-and-effect relationship between firearms and suicide? ### Analysis of food industry framing in WHO consultations



Commonalities in responses to WHO consultations:

- Regulation too simplistic
- Self-regulation preferable
- Restricting engagement harmful
- WHO overstepping mandate
- Policies infringe on national sovereignty
- NCDs are national responsibility
- In some cases responses almost identical across a range of trade groups

#### **Executive Summary**

Commercial actors can contribute positively to health and society, and many do, providing essential products and services. However, a substantial group of commercial actors are escalating avoidable levels of ill health, planetary damage, and inequity—the commercial determinants of health. While policy solutions are available, they are not currently being implemented, and the costs of harm caused by some products and practices are coming at a great cost to individuals and society.

A new *Lancet* Series on the commercial determinants of health provides recommendations and frameworks to foster a better understanding of the diversity of the commercial world, potential pathways to health harms or benefits, and the need for regulatory action and investment in enterprises that advance health, wellbeing, equity, and society.



#### 2023 Bridgetown Declaration on NCDs and Mental Health

To address negative trade-related and commercial determinants of health, SIDS need to act both individually and collectively to protect their regulatory and policy space in trade and investment agreements, and safeguard policymaking from industry interference and conflicts of interest. SIDS also need to support and enhance sustainable local food production and processing by responsible local commercial actors, including small-holders and family farms.

# Applying evidence toward greater policy coherence

- A great deal of nuance and complexity among private sector actors, across geographic contexts
- Strong parallels emerging in key harmful product industries in terms of strategies and impacts, that are not reflected in regulatory approaches, or conflicts of interest guidance
- This has a range of potential risks
  - Undermining partnerships more broadly
  - Ignores role in preserving between or within country inequalities
  - Undermining efforts to build more sustainable economic systems

## Potential opportunities moving forward

- Building of greater coalitions (including between member states/regions)
- Tools to aid member states in assessing impact of CDoH at regional, national and subnational levels
  - Widening access to essential goods and services
  - Building more equitable trade and IP frameworks
  - Greater monitoring of cross-border externalities
